- assign, transfer, convey, hypothecate, mortgage, pledge, charge or give security in any manner upon all or any real or personal property or other assets, movable or immovable, present or future, of the Trust to secure any such obligations of the Trust; F.

- 13. This resolution shall remain in full force and effect and be binding upon the Trust until Qtrade has received written notification, in form and substance satisfactory to them, that this resolution has been repealed or replaced.
